## **ACADEMICS**

#### GOALS

ENGLISH — 85% of students who attended the school for 2 or more years will score proficient or better on the state English language arts assessment in grades 3-8; each cohort of K-8 students will meet or exceed expected growth norms on NWEA's reading MAP assessment; 80% of K-8 students' proficiency will improve by at least 10% annually.

MATH — 85% of K-3 students who attended the school for 2 or more years will score proficient or better on state mathematics assessment; each cohort of K-8 students will meet or exceed expected growth norms on NWEA's math MAP assessment; 85% of students who attended the school for 2 or more years will score at the proficient level or above on the end-of-course mathematics exams in Algebra I and geometry; 80% of students' proficiency in math will improve by at least 10% annually.

#### **STATE REPORT CARD RATINGS**

Report cards for the 2021-2022 school year are the first to be issued featuring 1 to 5 star ratings rather than A through F letter grades. Consistent with the enactment of previous report card overhaul legislation, the new accountability system is being phased in over time to allow schools to adapt to new standards. For the 2021-2022 school year, only report card components were rated — schools did not receive overall ratings. The Northwest Ohio Classical Academy received ratings for four components:

**Achievement** represents whether student performance on state tests met established thresholds and how well students performed on tests overall.

**Progress** looks closely at the growth all students are making based on past performances.

**Gap Closing** is a measure of the reduction in educational gaps for student subgroups.

**Early Literacy** is a measure of reading improvement and proficient for students in kindergarten through third grade.

#### SPONSOR STATEMENT

St. Aloysius, as the sponsor of this school, is legally mandated to provide oversight, monitoring, and technical assistance.
