



Northwest Ohio Classical Academy (NOCA) is a Hillsdale College Curriculum School.

Moral Virtue

School culture demanding moral virtue, decorum, respect, discipline, and studiousness among the students and faculty.

Content-rich Curriculum

Teacher-led instruction that is content-rich, balanced and strong, across the four core disciplines of literature, history, math, and science.

A rich examination of the American literary, moral, philosophical, political, and historical heritage.

Introduction to Latin in 6th Grade. High school level Latin starting in 7th Grade.

ACADEMICS GOALS

Goal 1: By the end of the 2023-2024 school year, 50% of students will score proficient or better on the ELA and Math state assessments, or demonstrate at least 1 years growth annually on the NWEA Map test for ELA and Math. 50% of K-2 students will move to on-track students on the NWEA Map test for Reading and Math.

Goal 2: NOCA will continue to create a safe, student-centered, innovative learning environment and recruit, develop, and retain high quality teachers, By 2024, the School will create and maintain a comprehensive plan for engaging students, parents and community partners resulting in an overall attendance percentage of 93%, a staff retention rate of 90%, and a decrease in office referrals by 10%.

Goal 3: By the end of 2024, teachers and staff at NOCA will be provided with a formal process for a Professional Learning Community Plan that includes tailored procedures, development, and strategies that will promote teacher retention and increase student achievement by one proficiency level, as measured by NWEA score growth.

SPONSOR STATEMENT
